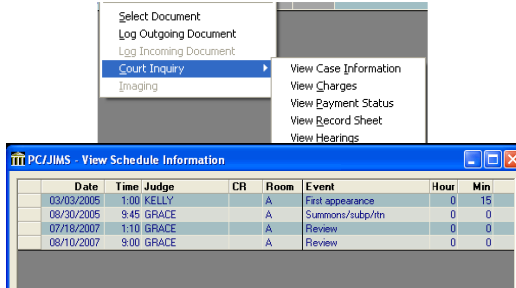
## Case Management System

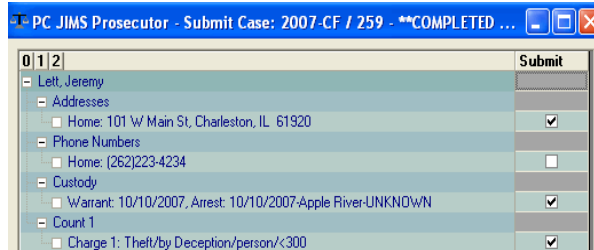
## Integration with Circuit Clerk data & documents

- View case data & documents
- Search clerk's hearings
- Import existing case data
  - Defendant data - name, address, DOB, etc.
  - Case Info - charges, dispositions, sentences
- Refresh your data to update with current Court data
- See a client's balance across all cases, and last payment date
- Import Clerk registered attorneys, judges and law enforcement officers
- Use with PC JIMS IMAGING\* for access to the Circuit Clerk's documents, audio and video, and for independent and secure storage of your own files/documents.



## E-File charging decisions and documents to the Clerk

- Electronically initiate and submit a case to the Circuit Clerk's system, indicating defendant name, demographics and charges.



## Master Charge Table

- Create and use master charge table narratives, such as those in the Uniform Complaint Book. Customize per case, as needed.

## Document Merge

Quickly produce documents from case data. Use Microsoft Word or Corel WordPerfect to create merge documents.
